Before moving forward, it is paramount to recap what we covered in 2021:

In a series of articles we spelt out how only the State Legislatures are the Parties to the Constitution, and gave you a few examples and documentation that pointed to this fact. Since the closing of sessions for 2021 we have seen the following issues:

- Rampant spending... on unauthorized stuff causing inflation stealing what little wealth citizens possess
- The invasion on our Southern Border causing a housing crisis
- The insatiable growth of the National Debt by uncontrolled spending on unconstitutional outlays
- CA and now NY are allowing illegals and NON-Citizens the right to vote
- Abortion has become the leading cause of death worldwide with 43 million in 2021 much of this is unconstitutionally funded by the federal government
- Every State's economy is being held hostage by unconstitutional exertion of power by the federal government
- New tyrannical taxes coming from the federal government such as:
  - a tax per mile you drive your car
  - Taxation on \$600 or greater transactions BTE this is the tip of the ice berg
- The preparations are underway to go to a cashless society
